Quotations are due by ***31 March 2023, 17:00 Local Time***. No quotations will be accepted after this time. Proposals must be in English and incomplete proposals will not be accepted.

Your quotation must be submitted electronically to ***TbilisiGSOProcurement@state.gov***. It is important to make sure the submission is made in specific size and format; in MS-Word 2007/2010 or MS-Excel 2007/2010 or Adobe Acrobat (pdf) file format. The file size must not exceed 30MB. If the file size should exceed the 30MB, the submission must be made in separate files and attached to separate emails with less than 30MB each.

In order for a quotation to be considered, you must also complete and submit the following:

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

SUMMARY

The US Embassy compound Fencing is the most important facility for the Embassy Operation by the means of physical protection and esthetical view of entire compound. Almost 5750 sqm concrete and 475-meter metal structure is fencing the entire territory and parking lots. Purpose of this project is renovating the painting on concrete and metal fencing of the Embassy area from inside and outside with durable and safe appropriate painting materials.

PAINTING THE WORKS

a. Preparation for Works

- i. Before working on each section of the perimeter fencing permission must be obtained from RSO representatives.
- ii. Scaffolding raised for painting the wall must be removed each day to prevent intruders.
- iii. RSO or LGF will Escort and guide the contractor painters Activities.

b. Renovation Process of Concrete walls. - 5750 sqm

1 Painting Walls to be Uniform with Existing color of wall paint.

1.1 Perform wall surface treatment and painting for the walls shall be 100% direct application (no diluted paint coating)

1.2 All walls' surfaces shall be cleaned and free of dust, grease, or other contaminants before painting. Peeled paint shall be removed with sandpaper and leave free of dust.

1.3 Contractor shall pre-wash all surface areas with high-pressure water before painting the surfaces.

1.4 All cracks and holes shall be filled in with appropriate wall filler or spackle (Pasta Mural a base de latex) and finished to match existing surface.

1.5 If there are deep fissures or cracks that affect the impermeability of the work in the area to be treated, sealants should be applied before the polyurethane elastic or pressure washer (if any) or any other liquid is applied. Spackle (pasta mural base de latex) and finished surface areas shall be a smooth even color.

1.6 Renew the concrete fencing temperature gaps with spatial silicone compound (EU or US Manufacturer) appropriate and designate for proper usage.

1.7 All areas shall require two coats of paint. Where it is needed or when existing layers of paint are removed, it shall be painted with appropriate sealer (EU or US Manufacturer) or primer (Sellador de Pared a base de latex) or other material so that finished surfaces are a smooth, even color.

1.8 Paint to be applied shall be, façade silicone paint (Embassy to add color specifications (EU or US Manufacturer)). Colors shall match the existing and samples of materials shall be previously approved by the Embassy. Paint shall be applied according to manufacturer's instructions and shall cover painted surface completely with no underlying colors coming through.

1.9 Paint shall be done with fine brushes or rollers. Avoid air compressed painting to eliminate contaminations on adjacent surfaces.

1.10 Embassy does not provide water and electrical power for this work. Contractors must have portable generators and water supply for entire project as well as electrical extension cords, of reliable, good quality and in good conditions. The use of extensions cords in bad conditions or improper connections will not be allowed. The Contractor shall provide all equipment and materials.

1.11 Contractors shall provide all equipment and scaffolds.

1.12 Painting areas are indicated on submitted CAD drawing (Embassy to provide). Paint areas include interior walls, and criteria are as follows:

1.13 All given measurements shall be confirmed by the Contractor. No amendments in the Contract shall be accepted due to a discrepancy with the measurements.

1.14 Upon completion of work, the area is to be returned to clean condition with no dust or paint stains and no excess paint drippings on floors, wall, installed equipment, outlets, or fixtures.

1.15 All retouching works should be included, and the area should be kept clean during and at the end of each working days.

1.16 Contractor shall remove and dispose of all excess material.

c. Renovation Process of Metal Fencing including Sliding Gates of CAC's. 475 LMeter

1.17 Painting Walls to be Uniform with Existing Metal Fencing paint.

1.18 Perform wall surface treatment and painting for the walls shall be 100% direct application (no diluted paint coating)

1.19 All Metal Fence surfaces shall be cleaned and free of dust, grease, or other contaminants before painting. Peeled paint shall be removed with sandpaper and leave free of dust.

1.20 Contractor shall pre-wash all surface areas with high-pressure water before painting the surfaces.

1.21 All cracks and holes shall be filled in with appropriate metal filler (EU or US Manufacturer) and finished to match existing surface.

1.22 If there are deep fissures\Rust or cracks that affect the impermeability of the work in the area to be treated, sealants (EU or US Manufacturer) should be applied before painting and finished surfaces area shall be a smooth and even color.

1.23 All areas shall require two coats of paint (EU or US Manufacturer). Where is needed or when existing layers of paint are removed, it shall be painted with appropriate sealer or primer or other material so that finished surfaces are a smooth, even color.

1.24 Paint to be applied shall be, Oil Based 3 component direct rust paint half matt(Embassy to add color specifications (EU or US Manufacturer)). Colors shall match the existing and samples of materials shall be previously approved by the Embassy. Paint shall be applied according to

manufacturer's instructions and shall cover painted surface completely with no underlying colors coming through.

1.25 Paint shall be done with fine brushes or rollers. Avoid air compressed painting to eliminate contaminations on adjacent surfaces.

1.26 Embassy does not provide water and electrical power for this work. Contractors must have portable generators and water supply for entire project as well as electrical extension cords, of reliable and good quality which are in good condition. The use of extensions cords in bad conditions or improper connections will not be allowed. The Contractor shall provide all equipment and materials.

1.27 Contractors shall provide all equipment and scaffolds.

1.28 Painting areas are indicated on submitted CAD drawing (Embassy to provide). Paint areas include interior walls, and criteria are as follows:

1.29 All given measurements shall be confirmed by the Contractor. No amendments in the Contract shall be accepted due to a discrepancy with the measurements.

1.30 Upon completion of work, the area is to be returned in a clean condition with no dust or paint stains or excess paint drippings on the floors, wall, installed equipment, outlets, or fixtures.

1.31 All retouching works should be included, and the area should be kept clean during and at the end of each working days.

1.32 Contractor shall remove and dispose of all excess material.

d. Renovation Process of Stone cover Walls (630 sqm) and change the damaged stones 10-15 % of entire stone cover, and Varnish.

1.33 Renovate the Stone cover with designated procedure:

1.34 Perform wall surface treatment and Varnish for the Stone covered walls shall be 100% direct application (no diluted paint coating)

1.35 All limestone area surfaces shall be cleaned and free of dust, grease, or other contaminants before covering. Peeled varnish shall be removed with sandpaper and leave free of dust.

1.36 Contractor shall pre-wash all surface areas with high-pressure water before painting the surfaces.

1.37 All cracks and holes shall be filled in with appropriate filler and finished to match existing surface.

1.38 All Damaged and non-repairable stone must be removed and changed with new one to match the existing Stone color and relief.

1.39 All areas shall require two coats of varnish (EU or US Manufacturer). Where is needed or when existing layers of cover are removed, it shall be varnished with appropriate sealer or primer or other material so that finished surfaces are a smooth, even color.

1.40 Varnish to be applied shall be, rated for outdoor use for Limestone with weather and direct sunshine (UV) protection half matt (Embassy to add color specifications (EU or US Manufacturer)). Colors shall match the existing and samples of materials shall be previously approved by the Embassy. Varnish shall be applied according to manufacturer's instructions and shall cover surface completely with no underlying colors coming through.


- 1.41 Varnish shall be done with fine brushes or rollers. Avoid air compressed painting to eliminate contaminations on adjacent surfaces.
- 1.42 Embassy does not provide water and electrical power for this work. Contractors must have portable generators and water supply for entire project as well as electrical extension cords, of reliable and good quality which are in good condition. The use of extensions cords in bad conditions or improper connections will not be allowed. The Contractor shall provide all equipment and materials.
- 1.43 Contractors shall provide all equipment and scaffolds.
- 1.44 Stone cover areas are indicated on submitted CAD drawing (Embassy to provide). Stone areas include interior walls, and criteria are as follows:
- 1.45 All given measurements shall be confirmed by the Contractor. No amendments in the Contract shall be accepted due to a discrepancy with the measurements.
- 1.46 Upon completion of work area is to be returned to clean condition with no dust or paint stains in evidence and no excess paint dropping on floors, wall, installed equipment, outlets, or fixtures.
- 1.47 All retouching works should be included, and the area should be kept clean during and at the end of each working days.
- 1.48 Contractor shall remove and dispose of all excess material.

e. Quality of Materials and Control of Renovation Process

- i. Contractor shall introduce the written procedure\job plan and drawings for approval.
- ii. Work schedule shall be detailed, time efficient, and approved by Embassy COR.
- iii. All Materials used, shall be high quality proved with certificates.
- iv. All Materials used, shall be approved\obey with\to US government fire and safety standards and certificates (electrical equipment's EL standard).
- v. Material samples shall be provided for approval prior to order.
- vi. Contractor shall be responsible for personal safety and workplace safety¹.
- vii. Embassy authorized personnel shall verify the condition of the safety equipment and workers behavior during the project period, and if serious\or repetitive safety violation occur, equipment will be blocked, or access of the offending individual will be restricted.
- viii. Embassy Quality control team members shall request from contractor documents showing proof of material quality and applicable measurement records.
- ix. Quality check inspections shall be carried out frequently to ensure the highest quality is delivered by the contractor.

(2) Have, have not, within a three-year period preceding this offer, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a Federal, state or local government contract or subcontract; violation of Federal or state antitrust statutes relating to the submission of offers; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, violating Federal criminal tax laws, or receiving stolen property;

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
