1. Brief information about the project

The multi-donor project “QUIS - Better Goods and Services” on enhancement quality infrastructure in Georgia (hereafter - QUIS) is jointly co-financed by the European Union, the Federal Ministry Economic Development BMZ and Czech Development Cooperation (CDC) and implemented by GIZ and CzDA. The project timeline is scheduled till January 31, 2027.

Overall objective of QUIS is to ensure safety and promote inclusive and sustainable economic growth in Georgia through improved competitiveness of the private sector and implementation of the DCFTA and its EU related commitments, with a particular focus on business, trade, environment, and better skills matching.

Notably, QUIS targets the following outputs:

Output 1: Optimized regulatory and policy framework for quality infrastructure in line with EU and international requirements that promotes competitiveness of the Georgian products (goods and services).

Output 2: Improved compliance with European and international standards of conformity assessment bodies (incl. laboratories).

Output 3: Improved compliance with European and international standards of local producers.

Output 4: Raised awareness for Georgian companies regarding the potential of private standards or state regulation, including the services offered by public and private organizations within the system of notified bodies.

Output 5: Intensified cooperation between quality infrastructure institutions and private sector actors.

The partner of the project at the political level is Georgian Ministry of Economy and Sustainable Development (MoESD). Narrower portfolio of partners encompasses public bodies supervised by MoESD, such as Georgian National Agency for Standards and Metrology (GeoSTM), Georgian Accreditation Center (GAC), Market Surveillance Agency (MSA), Georgian Competition and Consumer Agency (GCCA) and Enterprise Georgia (EG).

2. Context and objective of the assignment

Scope of QUIS covers Conformity Assessment Bodies (CABs) development program, including building capacity of testing and calibration laboratory services, which is capital-intensive activity per se, requiring investment in fixed assets and marginal operational expenses. Thus, the project is determined to support this area of market failure and introduce financial mechanism(s) bundled with technical assistance (TA) to strengthen conformity assessment services and generally quality infrastructure in the country. Consequently, financial support will be granted to testing and calibration laboratories, aiming to meet the demand and contribute to overall quality infrastructure.

For this reason, GIZ will contract an expert to do research with the private sector on aspects related to the conformity of industrial or consumer products.

The objective of this action is to have small-scale research on existing situation on aspects related to the conformity of industrial or consumer products and services (driven by regulatory requirements or intrinsically) provide comprehensive analysis of existing situation regarding the conformity with requirements for businesses in woodwork/furniture/toys sectors.

The focus of the research is to visit some of the local Georgian small and medium size enterprises active in woodwork/furniture/toys sectors, gather the information regarding the production and services offered, identify their needs, challenges and opportunities regarding the conformity with requirements for these business sectors and support them in their further sustainable development through networking, promotion and access to knowledge and expertise.

The mission is to support Georgian SMEs in woodwork/furniture/toys sectors while increasing their competitiveness in the local and international market as well as providing producers with tools and skills which allow them to be more competitive in terms of sustainability, product/service development, marketing, and international exposure/outreach.

3. Scope of work

Therefore, the objective of the assignment for the individual local expert is expected:

- a) Together with the GIZ advisor develop a preliminary data base of potential SMEs to be visited for the research in targeted sectors;
- b) Review the findings and results of work done previously in regard to conformity with requirements for businesses aspects in the sectors;
- c) Together with the GIZ advisor develop a questionnaire based on the information needed

to be gathered for the SME data base in the sectors as well as the needs assessment of SMEs in the sectors.

- d) Review the findings and results of the research conducted;
- e) Develop a set of recommendations and potential implementation plan for the SMEs;
- f) Assess individual SMEs and their individual needs in terms of certification, and conformity assessment services for the selected products with existing local and international requirements in the sectors, potential new product development, service development & market positioning locally and internationally;
- g) Identify the jewelry sector's needs in Georgia regarding quality improvement and export activities and provide actionable recommendations for potential project interventions.

7. Evaluation criteria

7.1 Evaluation criteria for a technical proposal

A technical proposal shall be evaluated based on the relevance of the chapters of the concept and work plan to include:

- a) Interpretation of objectives;
- b) Strategy of implementation;
- c) Work schedule and timelines;

7.2 Evaluation criteria for a bidder

7.2.1. Education

Higher education in Arts, History, Architecture, Design, crafts or a related field.

7.2.2. Knowledge and skills

- a) Strong research, analytical and report writing skills;
- b) Excellent communication, facilitation and moderation skills;
- c) Advanced computer skills including Microsoft Office and web-based applications;
- d) Excellent command of English & Georgian, both written and spoken.

7.2.3. Work experience

- a) Experience conceiving and implementing concepts of the product development consultation in woodwork, furniture, toys, crafts sectors
- b) Experience in working with creative Industries on business development and standardization/certification for local markets and export
- c) Experience in conducting the studies and research in the sectors mentioned above
- d) Experience in developing Interactive databases in various sectors
- e) Experience in researching and assessing potentials of competitive and cooperative opportunities and challenges for local producers
- f) Preferably, 5 years of consulting experience in private sector development in the woodwork, furniture, toys, crafts sectors
- g) 5 years of Development Cooperation (DC) experience, working on development cooperation projects funded by international donors.

8. Data Protection, Coordination and Visibility

Contractor reports to QUIS Advisor and Team Leader at GIZ. The Contractor shall reach out relevant companies via own channels and ensure successful recruitment.

This activity is funded by the EU and German Government and must follow communication and visibility requirements of the donors (i.e. inclusion of logos and disclaimers).

The performance of the contract may be associated with the processing of personal data by the contractor, such as (but not limited to) names and contact information and who would alone define the nature of such data and how such processing would be carried out.
