1. 2. The Contractor shall provide English language classes for approximately 75-100 members of the Local Guard Force. Lessons shall be given at a firm fixed price per / session as specified below. Sessions shall be two (2) hours in length scheduled between the hours of 9am and 9pm. Specific dates will be provided on which classes may be scheduled. Once class schedule is agreed upon by COR and contractor, no changes to the dates will be permitted by the company. Embassy may request changes with 1-week notice. No more than 10 students will be part of any class, unless mutually agreed upon by the Contractor and the Government. Estimated annual number of lessons will be 450. The minimum guarantee would be 100 lessons.

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

2. PERFORMANCE WORK STATEMENT

The contractor shall provide English language classes for 75-100 members of the Local Guard Force, divided into Beginner and Intermediate and following a specific set of dates provided by the U.S. Embassy. Classes may be further divided to accommodate skill levels as agreed up by contractor and COR.

The contractor will provide classroom meeting space. Classrooms shall have adequate seating, desks, (climate control, audio-visual etc.)

Due to unique work schedules, classes will occur according to specific dates provided by U.S.

Embassy to accommodate students' work schedules. The contractor will choose 25 dates from the dates provided. Classes can be scheduled Monday through Sunday, but not on official Georgian holidays. Classes will be scheduled between the hours of 9am and 9pm. The specific dates that classes can be scheduled are attached. Once decided, no changes to the dates will be permitted by the contractor without COR approval. Embassy may request changes with 1-week notice.

The contractor will test students to determine placement in Beginner or Intermediate levels. The contractor will provide test results to Embassy. Using test results, Embassy will divide students into groups and provide number of groups, attendee list, and group schedules as corresponds with the specific dates as determined by Embassy (see above).

The contractor will provide all instructional materials including texts, class exercises, handouts, tests, and audio-visual media. Instructors will require homework of students. Instructors should be prepared homework to accommodate highest and lowest levels in a class. The curriculum and materials will be approved by the Contracting Officer Representative.

Beginner groups (approximately 4-5 groups) and Intermediate groups (approximately 4-5 groups) will alternate each quarter. For example: 1st and 3rd quarter will be Beginner groups, 2nd and 4th quarter will be Intermediate.

Number of groups and students per class to be determined based on testing, but size of classes will not exceed 10 (ten) students.

Classes will be 2 hours each. Classes will meet 25 times each quarter (3 months). Each quarter (3 months) will have 5-6 groups. Each quarter will have a maximum of 300 contact hours.

The objective of each training module or lesson should be: Beginner – basic conversation, common embassy specific safety, security, and drill words and phrases. Intermediate – intermediate conversation, more complex embassy specific safety, security, and drill words and phrases. Embassy will provide safety and drill words, phrases, and scenarios to supplement vocabulary and exercises provided by the contractor.

At the end of each quarter, instructor will provide suggestions to students for how to retain and/or grow their knowledge during the break.

Cancellation Policy - If an instructor cannot attend a class, the contractor shall provide a substitute teacher (all courses should be planned before start of each quarter; as such, any instructor should be able to teach the material from the plan). If embassy needs to cancel a class, it will give 12 hours' notice.

3. PERIOD OF PERFORMANCE

Class shall be given between the hours of 9am and 9pm Monday through Sunday. Embassy will provide specific dates to choose from. Multiple classes will be held each day, based on number

of students in each level. Contractor will choose 25 dates from each quarter. An example of possible dates are attached.

4. CONTRACTOR FURNISHED PROPERTY

4.1 The Contractor shall provide all instructional materials including texts, class exercises, handouts, tests, and audio-visual media.

4.2 The Contractor shall provide all necessary site support materials and equipment, including items such as:

flip chart and easel,
chalkboard or erasable marker-whiteboard,
videocassette player,
overhead projector, and/or
expendable/consumable classroom supplies (i.e. paper, pencils, pens, chalk, markers and binders).

The Contractor shall replenish such expendable/consumable items as needed to provide for the performance of the work.

4.3 The Contractor shall provide, within metropolitan area of Tbilisi, all needed classroom space to include all furnishings necessary for a proper learning atmosphere.

4.4 The Contractor shall provide qualified instructor(s), who are well versed in all topics to be covered (not including Embassy specific vocabulary and scenarios), capable of answering in-depth questions on each topic, will provide the required training in a classroom setting, based on the schedule of training modules or lessons and the objectives and goals for that training.

4.5 The Contractor shall provide instructor supervisor(s) who will supervise the performance of work under the contract, and who will perform quality assurance in meeting the objectives and goals for that training.

4.6 The Contractor shall provide other required classroom materials such as newspapers, magazines, dictionaries, or photocopied materials, written in English for use by students in exercises or testing.

5. SPECIFIC TASKS

The Contractor shall provide instructional Foreign Language Training services at the firm fixed prices shown in this contract. The objective of each training module or lesson is to prepare all students as efficiently and effectively as possible to accomplish the goals of the training. Contractor should provide general topics and vocabulary supplemented by job specific topics, vocabulary, and scenarios provided by the Embassy.

5.1 GOALS OF FOREIGN LANGUAGE TRAINING – BEGINNER LEVEL

Focus is on building confidence in basic verbal communication in English for the purposes of initial contact and in emergency and/or drill situations.

ORAL RECOGNITION AND RESPONSE

When addressed in English, the student will be able to recognize basic commonly encountered phrases and questions with the English-speaking public and some basic words and phrases specific to Embassy duties, provided by the Embassy. The student must then respond appropriately, providing acceptably worded and pronounced verbal responses, answering the questions asked, or providing information as needed. Student will be able to give very basic commands as relevant to their duties. At least 90% of the students completing training will be able to recognize and respond appropriately to at least 95% of the selected vocabulary, in 95% of the occurrences in which the selected vocabulary is presented.

READING RECOGNITION AND COMPREHENSION

Students will be able to recognize designated basic key phrases or questions in English, commonly encountered in both initial contact situations and in emergency and/or drill situations. At least 85% of the students completing training for each class will be able to comprehend and appropriately respond to at least 90% of the communications in which the selected vocabulary is presented.

5.1.2 GOALS OF FOREIGN LANGUAGE TRAINING – INTERMEDIATE LEVEL

Focus is on building intermediate verbal communication in English and reducing grammatical errors in general conversation and in emergency and/or drill situations.

CONVERSATION AND SUBJECT MATTER COMPREHENSION

The student will be able to communicate intermediate level key phrases or questions in English, both from common conversations and from Embassy provided scenarios specific to job duties. The student must then respond appropriately, providing the requested information. At least 85% of the students completing training for each class will be able to comprehend and appropriately respond to at least 90% of the communications in which the selected vocabulary is presented.

TRANSLATION, SUMMARIZATION, AND RESPONSE SELECTION

After reading intermediate English level dialogs, letters, news articles, etc., the student will be able to comprehend, translate, and correctly summarize the purpose and content of the written communication that was provided. The student must be able to translate the requested information and prepare a written response to the selected communication. At least 75% of the students completing the training shall correctly recognize, comprehend, and summarize the written communication, and to translate the correct response to the written communication at least 85% of the time.

5.1.3 STUDENT TESTING

The Contractor shall administer tests on knowledge and proficiency as a required element of evaluating the student's progress in the training module or lesson. The Contractor shall provide these tests periodically to:

- determine the student's progress in training;
- identify areas of weakness where supplemental training may be needed; and,
- quantify the student's then-current level of knowledge and proficiency.

Initial testing will be used to establish a baseline for measurement of knowledge and proficiency obtained and may be used in a predictive manner to facilitate personal training planning.

5.1.4 STUDENT PROGRESS DOCUMENTATION AND TRAINING RECOMMENDATIONS

The Contractor's instructor(s) shall be responsible for documenting each student's progress in training, and for preparing a training recommendation for each student. The student's progress will be reported to the student biweekly. This may be delivered via email or printout. The instructor will document the student's progress as measured performance under each lesson module. The Contractor shall prepare training recommendations that state specific plans for remedial, or supplementary use of supportive training materials, or use of tutoring and personalized training techniques.

5.1.5 STUDENT COUNSELING

The Contractor's instructor(s) shall provide weekly counseling to all students considered in danger of failing the proficiency tests. Counseling will include a discussion of the student's performance and corrective actions which may assist the student in the improvement of their performance. The counseling sessions should result in specific tasking for remedial, or supplementary use of supportive training materials, or use of tutoring and personalized training techniques, as needed to improve student performance. The Instructor shall document the training recommendations made to direct the student's progress.

5.1.6 CONTRACTOR REPORTING TO COR

Contractor will provide bi-weekly attendance records and general progress reports to include items like test scores and test materials that occurred in the previous 2 weeks, as well as discussions of low and high performers.

7.1. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

(3) If the Offeror checked “does” in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible website(s) where greenhouse gas emissions and/or reduction goals are reported: _____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414

(Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) *Representation*. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (*e.g.*, agency Office of the Inspector General).
