## Annex 2 - General scheme of bid evaluation

The offers received will be evaluated according to both prices and content. After the technical evaluation , the price offers of bidders will be opened and evaluated. The expenses that are made in accordance with the Terms of Reference must be clearly and detailed shown in the price offer.

# In the final overall assessment, the technical offer has a weighting of 70%, the price offer of 30%.

After that, the companies are given a ranking number based on the evaluation results. Contract negotiations will be initiated with the company with the best scores. If the negotiations are unsuccessful, negotiations will be conducted with the candidate in 2nd place.
