1. Context

a. Background information about the project

With its 'Community of Practice for Sustainable Urban Development', the international city platform - Connective Cities (CC) supports a systematic and application-oriented exchange of information and experience on urban solutions between urban actors and practitioners from politics, administration, business, science and civil society in all regions of the world.

Since 2013, Connective Cities has been a cooperation project of the German Association for International Cooperation (GIZ), Engagement Global with its service agency Communities in One World and the German Association of Cities and Towns commissioned by the German Federal Ministry for Economic Cooperation and Development (BMZ), which has been extended until March 2022. The implementing partners include selected regional and national associations of cities in Asia, Africa, the Middle East, Southeast Europe and Latin America as well as their member cities.

The project is designed in response to the world's growing population, an unprecedented scale of urbanisation and climate change that are contributing significantly to the fact that municipalities around the world are facing new challenges in urban development. Dealing with these challenges is central to the implementation of Agenda 2030 with its global Sustainable Development Goals (SDGs) and the associated global target systems (Paris Climate Agreement, New Urban Agenda, Sendai Framework for Disaster Risk Reduction).

Through dialogue and learning formats, the Cities Platform aims to mobilize German and international know-how in the field of urban development and

- Provide a portal for the dissemination of experiences with practical relevance
- Identify and network relevant actors in developing, emerging and industrialized countries.
- Promote and moderate specialist and regional working groups,
- Facilitate the exchange of information through international conferences, training courses and study trips
- Offer support in the development of innovative projects,
- Offer help in finding financing possibilities for the implementation of project ideas and
- Evaluate new project approaches and thereby contribute to making use of the experience gained in the learning process

b. Initial situation

In view of the global risk of infection with the corona virus, international, physical exchange formats are not possible at present and will probably also be allowed only to a very limited extent in the course of 2020. Against the background of the corona pandemic, it is very important to exchange experiences and innovative solutions quickly and efficiently across regions, so that cities in partner countries can better prepare for the effects of the pandemic or make their response to local infections more efficient.

In order to allow the planned exchange and to continue the ongoing learning processes in the five world regions (Sub-Saharan Africa, Middle East, Southeast Europe and Caucasus, Latin America and Asia), the international city platform Connective Cities plans to implement virtual formats of various kinds.



2. The task definition for contractor

The Contractor is responsible for providing the following services:

Part 1: Moderation within the framework of the learning processes of Connective Cities:

1. Concept design, implementation and moderation of virtual events within the framework of the learning processes of Connective Cities in the respective field in cooperation with the project team of Connective Cities (10 FT)

Part 2: Research, concept development and moderation of virtual events in the field of health, business and governance as part of the pandemic response at municipal level

- 2. Research and identification of 10 good practices, solutions or good experiences in the project partner countries globally, according to the quality standards of the project in the field of health, business and governance on the topic of municipal pandemic response and/or within the regional networks of Connective Cities (20 FT)
- 3. Mobilize the relevant cities and their representatives in partner countries to participate in Connective Cities virtual events and to present their project ideas or good practices to the wider audience
- 4. Development of the methodical-didactical concept, moderation of at least 5 virtual formats (1-day events) (15 FT)
- 5. Support the digital preparation of the events for display on the CC website and social media and processing of good practices and/or capacity building in cooperation with the project team
- 6. Conduct reporting and the final documentation of the complete series of the pandemic exchange of experience (5 FT)

- Elaboration of the methodology of the study/research
- Elaboration of questionnaires/surveys
- Create the comprehensive structure of delivering on the results

The final payment will be made as of 15.12.2020 based on the completion of the requested services (incl. virtual events organization) and a submission of a final report. All reports shall be produced in English. The Contractor shall report to the Principal regularly in accordance with the 2017 General Terms and Conditions of the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH attached to this ToR.

3. Submission of the proposal and personnel concept
