I.Scope of Services - U.S. Embassy Tbilisi is seeking proposals for a solution to upgrade our existing analog radio network to a UHF digital platform. The proposal must also include ondemand maintenance for hardware or system problems as well as routine/preventative maintenance.

The radio upgrade project also needs to ensure seamless communication between the Digomi, Vake, Downtown Freedom Square, and out to the airport areas.

The vendor will provide all equipment and software required. The U.S. government is not allowed to use equipment from a wholly owned Chinese company such as Huawei. Our preference is that the vendor will supply Kenwood equipment to be compatible with our existing radio equipment and personnel are already familiar with this equipment.

The Contractor shall use existing equipment when technically suitable and provide two quotes, one quote utilizing as much existing equipment as possible, and a second quote with all new equipment.

The Contractor shall complete all work, including furnishing all labor, material, equipment, and services, unless otherwise specified herein, required under this contract for stated services within the time specified herein. The price listed below shall include all labor, materials, overhead, and profit. In consideration of satisfactory performance of all scheduled services required under this contract, the Contractor shall be paid a firm fixed price for all services.

II. Base Period 12 Months from the date of contract award

I.Scope of Work

The scope of work for the radio upgrade project entails design, providing equipment, installation, and training for U.S. Embassy Tbilisi key personnel. The vendor is also expected to perform preventative maintenance on the radio network and to have enough spare equipment on hand to replace defective equipment within a reasonable time. We define a reasonable timeframe to be within 48 business hours for all equipment. The selected vendor shall be responsible for providing a proper design to ensure seamless communication throughout most of Tbilisi. The day-to-day management of hardware and software should be managed locally by embassy personnel with minimal support from the vendor.

The Embassy expects to need a minimum of two (2) radio repeaters, 60 handheld radios, and 8 vehicle radios, spare battery for each handheld radio, UPSs for base stations and radio repeaters, and 10 multi-unit handheld chargers. The radios need to operate with the following UHF frequencies:

The radio repeaters must have at a minimum 30 minute of battery backup units.

Specific deliverables and milestones will be listed in the Work Requirements and Schedules and Milestones sections of this SOW.

II. PERIOD OF PERFORMANCE.

U.S. Embassy Tbilisi anticipates a phased approach to this project. Each phase represents anticipated tasks and milestones. US Embassy Tbilisi reserves the right to modify each phase, individual tasks, phase order and priorities within each phase/task before or during contract negotiations. Order of execution for each phase may not be consecutive and/or may occur simultaneously. Lengths of phase extensions are subject to US Embassy Tbilisi approval.

The period for full implementation for the project is 5 months beginning from the date of Notice to Proceed (NTP). Once the project is completed and accepted by the Embassy, we will enter into an annual contract with four option years. All work must be scheduled to complete within this timeframe. Any modifications or extensions will be requested through U.S. Embassy and General Services Office (GSO) contracting officers for review and discussion.

III. Summary of Stages

Stage 1 – The installation period. The selected vendor shall assist the U.S. Embassy Tbilisi with installing a UHF Digital radio network within the frequency range of 451.200 - 461.525. The installation will include all hardware and software needed, radio repeaters, and the make and models of all radio equipment to be used. The U.S. Embassy Tbilisi is not allowed to have or use any equipment provided by a wholly owned Chinese company. Our preference is for the vendor to utilize Kenwood to be more compatible with our Embassy radio network.

During Phase 1, the U.S. Embassy Tbilisi will designate a single office (e.g. Regional Security Office [RSO]) to start working with the vendor on the installation and coverage areas. During this phase, U.S. Embassy Tbilisi will provide the Contractor with access to the Embassy compound and provide any other details on equipment or design necessary. Phase 1 shall be completed within two months of its start date.

Stage 2 – Training and Operational Performance Review. The Contractor shall begin training U.S. Embassy Tbilisi key personnel on the use of the radio equipment U.S. Embassy Tbilisi unit. During Phase 2, Contractor shall test and verify functionality and confirm functionality with U.S. Embassy Tbilisi LGF staff. Phase 2 shall be completed within one month of the phase's start date.

Stage 3 – U.S. Embassy Tbilisi local guard force (LGF) personnel shall begin utilizing the radio network during their normal business. During this phase we expect the contractor to be available to make any necessary adjustments in coverage area, software, or radio programming. Phase 3 shall be completed within one month of the phase's start date.

Stage 4 – The contractor will remove all legacy radio equipment and turn it over to the U.S. Embassy Tbilisi for disposal. Phase 4 shall be completed within two weeks of the phase's start date.

IV. PLACE OF PERFORMANCE

The selected vendor for the radio upgrade project will perform most of the work at Chancery compound and selected repeater installation sites to be recommended by the vendor. The vendor will be required to meet at U.S. Embassy Chancery once per week (day and time TBD) for a weekly status meeting during the initial project. Additionally, all project reviews will be held at U.S. Embassy Chancery or virtually and attended by the vendor. The RSO will coordinate and provide and arrange for meeting spaces within its facility for all required vendor meetings. Once the project reaches the training phase, all training will be conducted at US Embassy facilities.

V. WORK REQUIREMENTS

As part of the radio upgrade project the vendor will be responsible for performing tasks throughout various stages of this project. The following is a list of these tasks which will result in the successful completion of this project:

Design Phase:

- Work with U.S. Embassy Tbilisi stakeholders to gather requirements and establish metrics
- Create design based on collected requirements
- Develop site design proposal for U.S. Embassy Tbilisi review and approval
- The design must include the make and model of equipment that will be utilized
- Coverage map for the intended design

Kickoff:

- Vendor will create and present detailed project plan including schedule, WBS (Work Breakdown structure), testing plan, implementation plan, training plan, and transition plan
- Vendor will present project plan to U.S. Embassy Tbilisi for review and approval

Build Phase:

- Vendor will source all needed requirements and resources, including hardware, software, UPS.
- Vendor will bring all solution media to be scanned and cleared by Information Resource Management (IRM).
- Vendor will discuss implementation steps with RSO and IRM management and apply all recommendations and security concerns.
- Vendor will compile a testing report to present to U.S. Embassy Tbilisi for review/approval.
- Vendor will program all radios.

- Vendor will deliver handhelds to the Embassy and coordinate an installation date for the vehicle radios. (This might need to happen over several days as vehicles are in constant use).
- Vendor will install stationary bay stations (i.e. desktop) in two locations on the Chancery compound.
- Present written status at weekly meeting.

Implementation Phase:

- Vendor will implement the designed solution on U.S. Embassy Tbilisi Facilities.
- Vendor will begin providing support at this point forward until the end of the period of performance.
- Present written status at weekly meeting.

Training Phase:

- Vendor will provide training in accordance with approved training plan provided in the kickoff.
- Present written status at weekly meeting.

Training Outlines

- 1. The Contractor shall provide all system training for U.S. Embassy Tbilisi key personnel at a location in Tbilisi to be determined by U.S. Embassy Tbilisi.
- 2. The US Embassy Tbilisi anticipates training will be needed as follows for each project phase:
 - a. Prior to start of Stage 2, train nominated employees from LGF on how to use both handheld and vehicle radios.
 - b. Prior to start of Phase 3, train nominated employees per unit for the remaining US Embassy Tbilisi offices.
 - 3. The Contractor shall provide digital copies of all training/operating manuals.
- 4. The Contractor shall grant the U.S. Embassy Tbilisi rights to reproduce all training, operation and repair manuals as needed for its employees use.
- 5. The U.S. Embassy Tbilisi may request additional training beyond what is currently projected. The potential vendor should include in its cost proposal a per-hour fee for additional training services and explain in their proposal response how many persons can be trained at one time for the cost specified.
- 6. The potential vendor shall submit a training plan that includes but is not limited to the following: 1) Recommendation of training schedule, including how far in advance of each phase employees should be trained 2) the amount of hours needed for training, 3) Suggested hours and frequency needed refresher training, training of new employees and system/software upgrades.

Project Handoff/Closure:

• Vendor will provide U.S. Embassy Tbilisi with all documentation in accordance with the approved project plan.

- Vendor will remove all legacy radio equipment from the Embassy compound and all outside locations and turn over the equipment for disposal to the Embassy.
- Vendor will present project closure report to U.S. Embassy Tbilisi for review and approval.
- Vendor will complete the project requirements checklist showing that all project tasks have been completed.
- Present written status at weekly meeting.
- At the end of the contract, the Contractor will supply to the U.S. Embassy Tbilisi any and all media including any back up media in its possession containing information belonging to the US Embassy Tbilisi.

VI. RADIO UPGRADE PROJECT

The proposed solution shall include, but is not limited to the following integration parameters:

- A UHF digital radio network within the same frequency range as existing radio network
- A seamless radio communication network around the greater Tbilisi area.
- Routine preventative maintenance provided by the selected vendor.
- Ongoing maintenance/replacement of failed equipment.

A. Contract Period

1. U.S. Embassy Tbilisi would like to contract the proposed radio network from the Contractor for an initial period of 1 year upon successful implementation of the network with 4 options years.

2. U.S. Embassy Tbilisi expects that there will be no limit on the number of radios connected to the system.

3. Upon completion of the contract, the vendor shall deliver to the U.S. Embassy Tbilisi all software and hardware used for disposal.

4. The licensed software shall be compatible with Microsoft Window (all approved versions).

5. The U.S. Embassy Tbilisi shall have the right, at no additional cost, to operate simultaneously on, move, or upgrade the licensed software to other hardware platforms n which the licensed software may operate.

6. The vendor must ensure that all software and hardware utilized has a valid license for the period of the contract.

B. General Specifications

1. Equipment

- a. Coverage will include downtown, Vake, Subortalo, Digomi, Zurgovani, and corridor to the airport.
- b. Radio repeater in the frequency range of 451.200 461.525KHZ
- c. 60 number of handheld Radios
- d. 8 vehicle mobile radios
- e. Two repeaters
- f. 2 Base Stations

- 2. Additional Radio Equipment
 - a. The vendor will provide batteries for each handheld radio and at least one spare battery as well.
 - b. Vendor will provide universal power supply (UPS) units for both base station (I.e. desktop) radios and/or repeaters.
 - c. Vendor will provide 10 multi-unit (at least five radios) charger stations and 20 single charger stations.

C. Digital Radio Documentation

1. The Contract shall fully document all standard software functionality and instructions in their operating manual or provide vendor operating manuals.

VII. ACCEPTANCE CRITERIA

For the radio upgrade project, the acceptance of all deliverables will reside with U.S. Embassy Tbilisi's RSO. The RSO will coordinate with IRM and the vendor to ensure the completeness of each stage of the project and that the scope of work has been met. Once a project phase is completed and the vendor provides their report/presentation for review and approval, the RSO will either sign off on the approval for the next phase to begin, or reply to the vendor, in writing, advising what tasks must still be accomplished.

Once all project tasks have been completed, the project will enter the handoff/closure stage. During this stage of the project, the vendor will provide their project closure report and project task checklist to U.S. Embassy Tbilisi's RSO. The acceptance of this documentation by U.S. Embassy Tbilisi's RSO will acknowledge acceptance of all project deliverables and that the vendor has met all assigned tasks.

Any discrepancies involving completion of project tasks or disagreement between US Embassy Tbilisi and the chosen vendor will be referred to both organizations' contracting offices for review and discussion.

VIII. INVOICING AN PAYMENT

a) The Contractor will be compensated for all work received and accepted by the Government. Summary invoice shall be submitted to

(b) A proper invoice must include the following information:

(a) If an invoice does not contain the above information, the Embassy reserves the right to reject the invoice as improper and return it to the Contractor within seven (7) calendars days for the Contractor to then correct and return the invoice.

(b) Payment shall be made in local currency by Electronic Funds Transfer (EFT) within thirty (30) days of receipt of a proper invoice.

IX. OTHER REQUIREMENTS

All vendor project team members will submit security forms to U.S. Embassy Tbilisi's RSO for clearance and access badges to the facilities. Access to embassy facilities is limited by the project closure date.

X. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(c) (1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying. In the absence of a completed IRS Form W-14 accompanying a payment request, the default withholding percentage is 2 percent for the section 5000C withholding for that payment request.

(i) Notify the Contracting Officer within 30 days of a change in circumstances that causes the Contractor to be subject to the excise tax withholding under 26 U.S.C. 5000C; and

(d) The Government will withhold a full 2 percent of each payment unless the Contractor claims an exemption. If the Contractor enters a ratio in Line 12 of the IRS Form W-14, the result of Line 11 divided by Line 10, the Government will withhold from each payment an amount equal to 2 percent multiplied by the contract ratio. If the Contractor marks box 9 of the IRS Form W-14 (rather than completes Lines 10 through 12), the Contractor must identify and enter the specific exempt and nonexempt amounts in Line 15 of the IRS Form W-14; the Government will then withhold 2 percent only from the nonexempt amount. See the IRS Form W-14 and its instructions.

Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. - (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of

military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

Service-disabled veteran-owned small business concern—



(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the
